FUNDS TO PREVENT HIV DISEASE

4201. SHRI VISHNU DAYAL RAM:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the funds allocated for prevention, care and treatment of HIV/AIDS during the last three years, State/UT-wise;
- (b) whether the funds being allocated to States for the purpose have been reduced by the Central Government;
- (c) if so, the reasons therefor;
- (d) the factors considered for earmarking funds for prevention, care and treatment of HIV/AIDS, State-wise; and
- (e) whether the HIV prevalence rate in the North Eastern States is higher than the average of India and if so, the details thereof and the reasons therefor?

(a) to (c): The overall funds allocated to the States/UTs under National AIDS Control Program (NACP) have increased from 913.10 crore in 2016-17 to 915.20 crore in 2017-18 and to 958.40 crore in 2018-19. State/UT wise allocation under NACP in the last three years is at **Annexure**. Over and above the funds allocated to States/UTs, HIV Test Kits and Anti-Retroviral Drugs are procured centrally and supplied to States/UTs.

(d): The funds to the States/UTs under the NACP are allocated in consultation with States/UTs AIDS Control Societies as per their Annual Action Plan. The Annual Action Plan takes into account the local situation across prevention, detection, treatment and retention services keeping community in the center and supported by critical enablers of laboratory services, strategic information and program management.

(e): Yes. As per the Government HIV Estimations Report for 2017, the HIV prevalence rate among 15-49 years old population in the North Eastern States is 0.24% in comparison to the national average of 0.22%. The HIV prevalence rate in the States of Manipur, Mizoram and Nagaland is 1.43%, 2.04% and 1.15% respectively. This is on account of high-risk behavior denoted by the injecting drug uses and unsafe sexual practices.
