NO. 866. SHRI DULAL CHAND GOSWAMI:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of the progress made in development works in cities identified to be developed as smart cities, State-wise;
- (b) whether the Government is demolishing the slums under this project;
- (c) if so, the number of slums demolished all over the country, Statewise, including State of Bihar;
- (d) the steps taken by the Government for the rehabilitation of the displaced families as a result of demolishing of the slums; and
- (e) the funds allocated for the rehabilitation and the money spent thereon, State-wise?

- (a): State/UT-wise details of progress made under Smart Cities

 Mission are attached in Annexure-I.
- and Colonisation being State subjects. State (b) to (d): Land Governments issue policies/guidelines or funds for slum re-No development. specific quidelines or funds for demolition/rehabilitation of the people living in slums have been issued under the Smart Cities Mission(SCM). Under SCM, all projects are proposed and implemented by the cities in accordance with the Mission Statement and Guidelines. With regards to Slum development projects, 27 cities out of the selected 100 Smart Cities have reported a total of 45 slum redevelopment projects at an estimated cost of Rs 3,967 crore. Some projects require re-settlement of slum dwellers. Their details, as per information provided by the cities, are given in Annexure-II.
- (e): No separate funds are allocated by the Central Government under SCM to the States/UTs for rehabilitation purposes, however, cities may allocate a part of the project cost for the purpose. Further, under Pradhan Mantri Awas Yojana, one of the verticals is related to slum re-development. When such projects are included, as a part of Smart City Proposal under convergence, benefits provided under PMAY-U are utilized by the concerned Smart Cities.
