- (a) Under the Pradhan Mantri Awas Yojana (Urban) [PMAY(U)], against an assessed demand of around 1.12 Crore houses in urban areas of the States/UTs, 93.00 lakh houses have so far been sanctioned, of which 55.40 lakh houses have been grounded and 28.06 lakh houses have been completed.**
