STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF THE STARRED QUESTION NO. *328 DUE FOR ANSWER ON 17.03.2020 IN THE LOK SABHA.

(a) to (c): During the last 2 years i.e. 2017-18, 2018-19 and in the current year (up to 31.01.2020) a total of 59 godowns/warehouses and silos (56 godowns and 3 silos) have been created in Public Private Partnership (PPP) mode for storage of foodgrains for Central Pool Stock. The year-wise and State-wise details are at Annexure-I.

Depending on requirement in specific areas and for modernization of the storage facilities, the Government implements following schemes under PPP mode for creation of storage facilities for Central Pool Stocks in the country:-

(i) Private Entrepreneurs Guarantee (PEG) Scheme

Under this Scheme, which was formulated in 2008, storage capacity is created by private parties, Central Warehousing Corporation (CWC) and State Government Agencies for guaranteed hiring by Food Corporation of India (FCI). No funds are allocated by Government and full investment is done by the private parties/CWC/State Agencies. After taking over of the storage facility by FCI, storage charges are paid for the guaranteed period of 9/10 years.

(ii) Construction of Steel Silos

Government of India has approved an action plan for construction of steel silos in the country for a capacity of 100 LMT in Public Private Partnership (PPP) mode for modernizing storage infrastructure and improving shelf life of stored foodgrains.

As against the assessed storage requirement of 6.24 Lakh Metric Tonnes (LMT) for Andhra Pradesh (4 months' requirement under Targeted Public Distribution System) the total storage capacity available in the State is 22.51 LMT. As such there is sufficient capacity for storage of Central Pool stock of foodgrains in the State.

As on 31.01.2020, a storage capacity of 1.13 LMT has been sanctioned/allotted in Andhra Pradesh under PEG Scheme. Against this, a capacity of 0.88 LMT has already been completed.

The status of storage requirements and capacity in Andhra Pradesh is at Annexure-II.
