- (a) whether it is a fact that an additional amount of Rs. 853.15 crore towards compensation for land acquired for the projects in respect of ten packages of Mumbai – Goa NH-66 in Raigad, Ratnagiri and Sindhudurg districts of Maharashtra has not yet been paid to the concerned farmers;
- (b) if so, the details thereof along with the reasons therefor; and
- (c) the time by which the said compensation is likely to be paid to the concerned farmers?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF LOK SABHA STARRED QUESTION NO. 75 FOR ANSWER ON 6TH FEBRUARY 2020 ASKED BY SHRI VINAYAK RAUT REGARDING “PAYMENT OF COMPENSATION TO FARMERS”

(a) to (c) : This Ministry had sanctioned about Rs. 4372 Cr. for land acquisition (LA) of NH-66 from Mumbai to Goa in 10 Packages involving total project cost of Rs. 11490 Cr. Till date respective competent authorities for land acquisition (CALAs) have declared 3G final award for an amount of Rs. 4588 Cr, out of which Rs. 4065 Cr. had already been deposited with CALAs by MoRTH. The project wise details of amount sanctioned, deposited and disbursed by CALA till date is annexed herewith. An amount of Rs. 395 Cr. deposited with CALAs could not be disbursed due to various reasons such as verification of actual beneficiaries, court/ arbitration cases between different parties. All out efforts are being made in consultation with the State Govt. to disburse/ release the balance compensation amount to projects affected people at the earliest.
