STATEMENT REFERRED TO IN REPLY TO LOK SABHA STARRED QUESTION NO.84* FOR 7TH FEBRUARY, 2020

The Ministry of AYUSH has presently no plan to establish a National Center of Excellence (CoE) in Ayurveda System in Kerala. The National Ayurveda Institute for Panchakarma at Cheruthuruthy in Kerala under the aegis of Central Council for Research in Ayurveda Sciences (CCRAS), an autonomous body under Ministry of AYUSH, has been established in 2017 by upgrading the earlier Regional Research Centre. Apart from the above institute, Ayurveda Research Institute for Mother and Child Health Care, Thiruvananthapuram is also functional under the aegis of CCRAS.

Further, under the Center Sector Scheme namely "Scheme for assistance to AYUSH organization engaged in AYUSH education/Drug development and research/ clinical Research etc. for up gradation to Center of Excellence (CoE)", Ministry of AYUSH has supported six Ayurveda institutions working in Kerala, as detailed below:

It is mandatory for getting the applications forwarded through the concerned State AYUSH Directorate and to have recognition from SIRO (Scientific and Industrial Research organization) or affiliation with the concerned University. The applicant organization should have a track record of at least five years of meritorious works in AYUSH sector.
