(a) and (b): Department of Food & Public Distribution (DFPD) extends price support for procurement of paddy and wheat for central pool which are procured by the Food Corporation of India (FCI) and State Governments/State Government agencies.

The details of procurement of paddy and wheat during Kharif/Rabi Marketing season 2018-19 & 2019-20 by FCI/State Governments/ State Government agencies is at Annexure-I.

Coarsegrains are procured at MSP by State Governments as per the procurement plan prepared in consultation with FCI and approved by the Central Government, subject to its distribution by the State Government under National Food Security Act (NFSA)/ Other Welfare Schemes (OWS).

The Minimum Support Prices of paddy, wheat and coarsegrains from crop season 2017-18 to 2019-20 is at Annexure-II.
