DELAY IN IDENTIFICATION OF VARIOUS HISTORICAL BUILDINGS

1618. SHRI RAVNEET SINGH BITTU:

Will the Minister of CULTURE be pleased to state:

- (a) whether it is a fact that there has been delay and other issues towards proper identification and listing of the various historical buildings which are more than 100 years old as heritage structures and their declaration as protected monuments;
- (b) if so, the details thereof of all such heritage structures which are more than 100 years old along with the status of their being declared as protected monuments, State/UT-wise;
- (c) whether the Government is taking any steps to ensure proper identification, prevention of damage and encroachment on such buildings and listing of such heritage structures as protected monuments; and
- (d) if so, the details thereof and if not, the reasons therefor?

- (a)&(b) Declaring any monument/site as a monument of national importance (centrally protected) is a continuous phenomenon. At present, 22 number of monuments have been identified for declaring as protected monument, the details of which are at Annexure.
- (c)&(d) In order to prevent any damage to monuments identified for Central protection, periodic visits are made by field offices and if required, assistance from District Administration is also sought. For notifying such monument, process is specified in the Ancient Monuments and Archaeological Sites and Remains Act, 1958.
