WELFARE SCHEMES FOR SENIOR CITIZENS

†233. SHRIMATI POONAMBEN MAADAM: SHRI S. VENKATESAN:

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) the details of the schemes being implemented by the Government for the welfare of senior citizens and elderly people along with the details of beneficiaries during the last five years, State/UT-wise, particularly in Gujarat and Tamil Nadu;
- (b) the amount of money allocated and utilized for each of these schemes during the said period, with special reference to Gujarat and Tamil Nadu;
- (c) whether Gujarat has requested to allocate more funds for the said schemes for welfare of senior citizens and if so, the details of action taken in this regard;
- (d) whether the Government is planning to introduce or implement more welfare schemes for senior citizens and elderly people across the country and if so, the details thereof; and
- (e) the number of old age homes functioning in Gujarat at present, district and location-wise?

ANSWER

MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SHRI RATTAN LAL KATARIA)

(a) & (b): This Department is implementing a Central Sector Scheme of Integrated Programme for Senior Citizens (IPSrC) since 1992, under which grant in aid is given to Implementing Agencies (IAs) such as NGOs/VOs/States/UTs through registered Societies for running and maintenance of Senior Citizens Homes/ Continuous Care Homes/ Mobile Medicare Units etc. The main objective of the Scheme is to improve the quality of life of Older Persons by providing basic amenities like shelter, food, medical care and entertainment opportunities etc. Details of funds released to IAs including in Gujarat and Tamil Nadu are at **Annexure-I.**

The Department has also launched a Central Sector Scheme namely "Rashtriya Vayoshri Yojana" (RVY) on 1st April, 2017 with the objective to restore near normalcy in the bodily functions of Senior Citizens, suffering from age related infirmities/disabilities. Physical aids and assisted living devices such as walking sticks, elbow crutches, walkers/crutches, tripods/quadpods, hearing aids, wheelchairs, artificial dentures and spectacles are provided free of cost to Senior Citizens belonging to BPL category. The Scheme is implemented through the

- 'Artificial Limbs Manufacturing Corporation (ALIMCO) (a Public Sector Undertaking under the Ministry of Social Justice and Empowerment). Funds under the Scheme of RVY are allocated to ALIMCO being the implementing agency for conducting assessment and distribution camps in selected districts in the country.
- (c) In the above two schemes, funds are released only to above mentioned implementing agencies and not to the State Governments. Therefore question of request from the Government of Gujarat for more funds does not arise.
- (d): The Department has recently launched the National Action Plan for the welfare of Senior Citizens (NAPSrC) to enable them to lead a life of dignity. It envisages programmes for financial security, healthcare and nutrition, shelter and welfare, protection of life and property, active and productive ageing etc. NAPSrC is to be implemented by the States and other implementing agencies
- (e): Details of old age homes functioning in Gujarat at present, district-wise and location-wise are given in **Annexure-II**
