Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

(a) whether the Ministry provides financial assistance to artisans to construct workshed and if so, the details thereof;

(b) the number of Khadi and other artisans benefited under the workshed scheme in Andhra Pradesh during each of the last four years and the current year;

(c) the total number of Khadi artisans who were provided assistance for construction of worksheds in the States of Assam and Gujarat under the workshed scheme for Khadi artisans during the last five years;

(d) the details of the steps being taken by the Government to promote Khadi products and their sale; and

(e) the details of production and sale of Khadi products in the Country, State-wise?

ANSWER

MINISTER OF MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI NITIN GADKARI)

(a): Yes Sir. Ministry of Micro, Small and Medium Enterprises (MSME) through Khadi and Village Industries Commission (KVIC) extends financial assistance to Khadi Institutions for construction of Worksheds to Khadi artisans under "Workshed Scheme for Khadi Artisans". The Scheme introduced in 2008-09 envisages providing sufficient space and congenial environment to artisans for smooth and fatigue free working leading to enhanced production and increased earning. The scheme is demand driven. The pattern of assistance under the scheme is as follows:

The steps taken by the Government to promote Khadi products and their sale are as follows:

1. KVIC provides Modified Market Development Assistance (MMDA) to the registered Khadi Institutions and Khadi artisans.

2. KVIC provides interest subsidy on the working capital loan availed by Khadi Institutions for undertaking production and sales activities under Khadi programme.

3. Eligible Khadi artisans are also provided Workshed for better work atmosphere and storing the materials.

4. For revival of sick Khadi Institutions assistance upto Rs. 9.90 lakh is provided to weak and problematic Khadi Institutions to bring them back to normalcy.

5. For the renovation and modernization of sales outlets run by KVIC, Khadi Institutions and KVIBs financial assistance are being provided under 'Assistance for Marketing Infrastructure' scheme.

6. **Rozgar Yukt Gaon (RYG)** – To give boost and generate employment opportunities in the villages through hand spun charkha, a new component 'Rozgar Yukt Gaon' under Khadi Vikas Yojana has been introduced with an objective to introduce enterprise-led model replacing subsidy-led model in 50 villages. As part of the scheme, the artisans will be provided with charkhas, looms, warping units, professional skills and administrative framework support to create employment opportunities.

7. To revitalize the Khadi sector with enhanced sustainability of Khadi, increased incomes and employment for spinners and weavers, increased artisans' welfare and to achieve synergy with village industries **KVIC is implementing Khadi Reforms Development Programme (KRDP).** Under the scheme Khadi Institutions are provided with infrastructure support and also working capital.

8. Scheme of Fund for Regeneration of Traditional Industries (SFURTI) was launched by M/o MSME for making Traditional Industries more productive, market driven and competitive by organizing the Traditional Industries and artisans into clusters. Khadi Institutions can avail the benefit of the Scheme to develop their infrastructure and enhance the earning of its artisans.

9. To improve design development of Khadi, the KVIC signed a MoU with National Institute of Fashion Technology (NIFT).

10. To bring in product development and create more employment opportunities in the Khadi sector convergence has been developed with Corporates like Raymond Ltd and Aditya Birla Fashion and Retail Limited (ABFRL).

11. The KVIC also organized exhibitions to extend marketing support of KVI products to the producer Khadi and V.I. units.

12. To create awareness of KVI Schemes among the people Khadi and Village Industries Commission organize seminars, workshops, awareness camps, Peoples Educational Programmes etc.

13. To ensure genuineness of Khadi "Khadi Mark" regulations have been notified by Govt. of India.

14. Sales outlets at domestic airports like Visakhapatnam, Lucknow, Ahmedabad and Varanasi have been opened.

15. Launched 'store app' through mobile application to facilitate the customers to locate Khadi India sales outlet at various geographical locations to increase foot falls at various stores under Khadi sector.

16. KVIC introduced Gift Coupons and Boxes, which create additional employment to the artisans by producing quality material, contribute significantly to sales and give a well packaged product to the hands of buyers.

17. KVIC has been catering to the need of Govt. departments and bulk buyers such as Railways, Defence, Health & family Welfare Departments, Paramilitary forces and other Central & State Govt. Ministries to increase the sale of Khadi products.
