†2361. SHRI JUGAL KISHORE SHARMA:

Will the Minister of JAL SHAKTI be pleased to state:

(a) the schemes implemented by the Government for drinking water and sanitation in Jammu and Kashmir at present;

(b) the details of the schemes especially in Jammu, district-wise;

(c) whether the Government has found any irregularities in these schemes; and

(d) if so, the details thereof?

ANSWER MINISTER OF STATE FOR JAL SHAKTI (SHRI RATTAN LAL KATARIA)

(a) Government of India, in partnership with the States, has launched Jal Jeevan Mission (JJM)to enable every rural household in the country, including UT of Jammu & Kashmir, to have potable water at service level of 55 litre per capita per day (lpcd) through Functional Household Tap Connection (FHTC) by 2024.

For rural sanitation across the country, including the UT of Jammu & Kashmir,Swachh Bharat Mission (Grameen) [SBM(G)] is also being implemented.

(b) The information about district-wise details of water supply schemes for all States/ UTs including Jammu & Kashmir (as reported by the respective State/ UT) are in public domain and available on the website: $https://ejalshakti.gov.in \rightarrow IMIS Reports \rightarrow Schemes handed over to Community.$

Under SBM(G), 11,79,450 Individual household latrines (IHHLs) have been constructed in Jammu & Kashmir from 02.10.2014 to 02.03.2020 and all the 7,262 villages have declared themselves Open Defecation Free (ODF). District-wise details are annexed.

(c) & (d) Water & Sanitation being State subject, State Govt. plan, design, implement, operate & maintain the rural water supply & sanitation schemes. Further, whenever any grievance is received in this regard, the same is forwarded to the respective State Government for appropriate corrective measures.
