- (b) whether the Government has spent any funds from the said revenues on the development of NHs during the said period and if so, the details thereof;
- (c) whether some States including Tamil Nadu have raised objections for collection of toll tax from NHs during the last three years; and
- (d) if so, the details thereof and the consultations undertaken with various stakeholders in this regard along with the outcome thereof?

(c) &(d) Government of Tamil Nadu has requested Ministry to exempt all State Government vehicles on duty and State Transport undertaking town buses from payment of user fee. The buses of Kerala State Road Transport Corporation are not paying user fee on fee plazas of NHAI. NHAI has taken up the issue several times with the State Government and has also raised claim on State Government of Kerala to reimburse the loss in toll revenue. Further, four fee plazas under public funded projects and one fee plaza under Public Private Partnership (PPP) project are non-operational in different states due to public agitation. The details of such fee plazas are as under-
