Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the number of orphanages being run by the Government across the country, State/UT-wise;
- (b) the details of orphanages run by the Union Government and the State Governments across the country, State/UT-wise;
- (c) the number of people working in such orphanages, State/UT-wise; and
- (d) the number of orphans living in the said orphanages run by the Union Government and the State Governments, State/UT-wise?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SRIMATI SMRITI ZUBIN IRANI)

(a) to (d): The Ministry of Women and Child Development is implementing a centrally sponsored scheme i.e. "Child Protection Services Scheme (CPS)" (erstwhile Integrated Child Protection Scheme) for providing financial assistance to State Governments/UT Administrations, with the objective to create a safe and secure environment for overall development of children in need of care and protection, which includes orphan/abandoned/surrendered children. Under CPS, financial assistance is provided to State Governments /UT Administrations for setting up and managing Child Care Institutions (CCIs) including Specialised Adoption Agencies (SAAs) by themselves or in association with Voluntary Organisations/Non-Governmental Organisations (NGOs). The details of persons working in such homes is not maintained centrally. However, funding support for 10 no. of staff for a unit of 50 children for Children Home and 11 no. of staff for a unit of 10 children for SAAs are being provided under the CPS Scheme. The total number of CCIs including SAAs alongwith the children residing in them supported under CPS, States/UT-wise is **Annexed**.
