DIGITISATION OF ANGANWADI CENTRES

†2622. SHRI MOHANBHAI KALYANJI KUNDARIYA:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) whether the Government has initiated digitization of data related to Anganwadi Centres (AWCs) across the country for their proper monitoring;
- (b) if so, the status of such an initiative, State/UT-wise including Gujarat;
- (c) the details of proposed implementing agencies and strategy employed to ensure timely digitization of AWCs;
- (d) whether the Government has prescribed any time period to complete digitization of said AWCs and if so, the details thereof; and
- (e) the steps being taken by the Government to improve the nutritional, educational and health status of children in AWCs?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

(a) to (d) The Anganwadi Services Scheme has a monitoring system component to track the physical progress of the scheme in respect of various input processes, output and impact indicators through a standardized Management Information System (MIS) through regular reports on monthly, quarterly and half yearly basis. To strengthen the monitoring of Anganwadi Services Scheme, revised MIS known as ICDS-Rapid Reporting System (ICDS-RRS) has also been introduced for capturing the data of Anganwadi Centres (AWCs) online. Under the ICDS-RRS, AWC is assigned an 11 digit unique code and login password has been allotted at the supervisor level to submit the monthly progress report.

In addition, under POSHAN *Abhiyaan*, ICDS-Common Application Software (ICDS-CAS) enables data capture, ensures assigned service delivery and prompts for interventions wherever required. The software allows capture of data from the field on the mobile phone of the Anganwadi Worker. It enables collection of information on ICDS service delivery interventions and its impact on nutrition outcomes in beneficiaries. ICDS-Common Application Software inter-alia captures data on weight and height of children, opening of Anganwadi Centres, distribution of Take Home Ration and attendance of children for pre-school education at Anganwadi. This data/information is then available on web-based ICDS-CAS dashboard on a near real time basis, for monitoring, to the supervisory staff at Block, District, State and National level, for action and decision making at their end. The dashboard displays data and provides reports on various programme areas to the administrative officers to interpret and use the information for improving service delivery.

State-wise status of implementation of ICDS-RRS and ICDS-CAS including state of Gujarat is at Annexure-I &II respectively.

National Informatics Centre Services Inc., company under National Informatics Centre, has been assigned with the task of design, development, implementation and maintenance of ICDS-RRS system. The mechanism to implement the project in States /UTs include regular review through Video Conference, meetings and field visits by officers of the Ministry/State Governments/UT Administrations.

(e) The child beneficiaries under the Anganwadi Services Scheme are provided Supplementary Nutrition in the form of Hot Cooked Meals (HCM) or Take Home Ration(THR) as per the guidelines of the Scheme. Monthly Village Health and Sanitation Day and Community Based Events are organised by States/UTs to improve status of nutrition of children. In addition, children (3-6 years) are provided non-formal Pre-School Education service in all AWCs. Funds @ Rs. 5,000/- per AWC per annum is provided to States/UTs for imparting non-formal pre-school education to the children.

ICDS-CAS, under POSHAN Abhiyaan, enables growth monitoring of children with the help of auto plotting of growth chart on the mobile application. It enables monitoring of nutritional status of children across the country on monthly basis. SMS (Short Message Service) is an integrated part of ICDS-CAS application wherein system generates alerts on predefined conditions such as static/negative growth that are sent to parents and field functionaries for cognizance
