#### **Environment Clearance for Industries**

#### 2728. SHRI CHANDRA PRAKASH CHOUDHARY:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) whether industries/factories are not being set up in the country especially in Jharkhand due to the environmental clearance or laws relating to environment and forests for industries;
- (b) if so, the details thereof, State/UT-wise including Jharkhand; and
- (c) the corrective measures taken by the Government to facilitate these companies to create jobs without harming environment?

### **ANSWER**

## MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI BABUL SUPRIYO)

- (a) & (b) As per the available information on PARIVESH, in the last 5 years, this Ministry has accorded Environmental Clearance to 2468 Category A projects out which 64 projects are located in Jharkhand.State/UT-wise details are annexed.
- (c) To facilitate creation of jobs without harming the environment, the project proponents are required to submit Environment Impact Assessment (EIA)/ Environment Management Plan (EMP) along with their application for environmental clearance and details of employment generation. These reports are appraised by the sector specific Expert Appraisal Committees (EACs) and only after careful analysis of all the aspects including their impact on environment; and social and economic benefits, EC is accorded to the project.
