 (a) to (c) Several international institutions such as Japan International Cooperation Agency (JICA), French Development Agency (AFD), Deutsche Gesellschaftfür Internationale Zusammenarbeit (GIZ), KfW Bank and the World Bank provide financial assistance for forest development projects aiming at increasing forest cover, conservation of biodiversity, rehabilitation of degraded forest areas, soil & moisture conservation measures, capacity building of forest officials and other stakeholders, creation of livelihood opportunities for forest fringe villagers and other measures for sustainable management of forests, etc.

> Details of forest development projects implemented by Forest Departments including Rajasthan during last three years and the current year with external financial assistance are enclosed in Annexure.
