COMPLAINTS REGARDING ILLEGAL MINING

2769. SHRI S. VENKATESAN:

Will the Minister of MINES be pleased to state:

- (a) the number of complaints received about illegal mining in the country during the last three years, State/ UT-wise;
- (b) the details of the action taken on these complaints, year-wise;
- (c) whether it is a fact that the number of cases of illegal mining have increased in the country during the said period but action has been taken registering a few cases only; and
- (d) if so, the action taken thereon?

ANSWER

THE MINISTER OF MINES, COAL AND PARLIAMENTARY AFFAIRS (SHRI PRALHAD JOSHI)

(a) to (d): Based on the quarterly returns on illegal mining submitted by various State Governments to the Indian Bureau of Mines (a subordinate office of this Ministry), the state-wise case details of illegal mining reported from the year 2016-17 to 2018-19 alongwith the action taken is given at Annexure.

It can be concluded from the table given at Annexure that the cases of illegal mining showed an upward trend from 2016-17 to 2017-18. However, it has shown a downward trend from 2017-18 to 2018-19.
