SHRIKANT EKNATH SHINDE TO BE ANSWERED IN LOK SABHA ON 11.03.2020 REGARDING ADARSH RAILWAY STATION SCHEME IN MAHARASHTRA

(a) and (b): 108 railway stations including small stations have been identified for development under Adarsh Station Scheme in the state of Maharashtra. These identified stations include 1 Halt Grade (HG), 62 Non-Suburban Grade (NSG) and 45 Suburban Grade (SG) railway stations over Western Railway, Central Railway, South Central Railway and South-East Central Railway.

(c): In the State of Maharashtra 12 stations in last three years and one station in current year have been developed under this scheme and the remaining stations are targeted to be developed by 2020-21. Funds are not allocated separately for Adarsh Station Scheme and various passenger amenities works are carried out under Plan Head-53 'Passenger Amenities'. However, Zone-wise details of funds allocated under Budgetary sources and expenditure incurred for this plan Head-53 'Passenger Amenities', including in the State of Maharashtra during last three years and current year are as under:
