ANSWER

वाणिज्य एवं उद्योग मंत्री (श्री पीयूष गोयल) THE MINISTER OF COMMERCE & INDUSTRY (SHRI PIYUSH GOYAL)

- (a): The details of the State/UT Governments that have formulated Startup policies as on 15th March 2020 are at Annexure-I.
- Since the launch of Startup India initiative on 16th January 2016, a total (b): of 28,979 Startups have been recognized by DPIIT as on 1st March 2020. The State/UT wise breakup of these startups is at Annexure-II. DPIIT launched the first edition of State/UT Startup Ranking Framework on 6th February, 2018 to encourage States and UTs to take proactive steps towards strengthening the Startup ecosystem within their jurisdiction. There were 38 action points categorized into 7 broad areas such as Startup Policy and Implementation, Incubation support, Angel and Venture Funding, Simplification of Seed Funding, Regulations, Easing Public Procurement and Awareness & Outreach. The ranking methodology created a healthy competition among States to further learn, share and adopt best practices. 27 States and 3 Union Territories participated in the exhaustive ranking exercise. The final rankings of SRF 2018 were announced on 20th December, 2018 and the States were felicitated by DPIIT. The details of the States/UTs in terms of their performance as per States Ranking Framework 2018 are at Annexure-III.
