**NH PROJECTS IN RAJASTHAN**

4367. SHRIMATI JASKAUR MEENA:  
SHRI NIHAL CHAND:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS

be pleased to state:

- (a) the number of ongoing/pending National Highway Projects in the country including Rajasthan during the last two years and the details thereof;
- (b) the funds allocated and utilised for these projects so far;
- (c) the target set in this regard along with the steps taken to achieve the same;
- (d) whether the Union Government has received proposals from the Government of Rajasthan to declare some roads as National Highways in the State ; and
- (e) if so , the details thereof along with the steps being taken in this regard ?

**ANSWER**

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS

**(SHRI NITIN JAIRAM GADKARI)**

(a) to (c) 1,440 sanctioned projects amounting to Rs. 5,85,582 crore having length 49,740 km are ongoing in the country, as of December 2019, which includes 63 projects amounting to Rs. 28,270 crore having length 3,820 km in the state of Rajasthan. The funds allocated & released during the last two years and current year are given at **Annexure-I**. Projects are given a time period of 2 to 3 years for completion. In order to ensure timely completion of the projects and their subsequent maintenance, regular review meetings are held in headquarter by Ministry/NHAI with Regional Officers, concessionaires /contractors. Further, various steps such as streamlining of land acquisition & environment clearances, exit for equity investors, premium re-scheduling, close coordination with other Ministries, revamping of dispute resolution mechanism are also taken for timely completion of projects.

(d) and (e) The Ministry keeps on receiving proposals from various State Governments/Union Territories (UTs), etc., including from the State Government of Rajasthan for declaration of State roads as new National Highways. Declaration of State roads as new National Highways can be taken up after finalization of the policy/guidelines which is under consideration by the Central Government depending on traffic, connectivity and techno-economic feasibility based on outcome of DPR.
