- (b) the funds spent till date out of the allotted funds, year and State-wise; and
- (c) the details of the projects launched, completed and cost incurred till date under the said programme, State-wise?

- (a) Government of India has launched the Namami Gange Programme in June 2014, with the total budgetary outlay of Rs.20,000 crore for the period from 2014-15 till 31 December, 2020.
