Programmes/Schemes for Minority Craftsmen and Artisans

714. DR. (PROF.) KIRIT PREMJIBHAI SOLANKI:

Will the Minister of **MINORITY AFFAIRS** be pleased to state:

(a) the details of programmes/schemes run by the Ministry for benefit of minority craftsmen and artisans;

(b) the salient features of above such programmes/schemes along with the current status of implementation in the country;

(c) the total number of minority craftsmen and artisans that have been benefitted thereunder since inception, State/year-wise especially in the State of Gujarat; and

(d) the steps taken by the Government, if any, to spread awareness regarding the same?

<u>ANSWER</u> MINISTER OF MINORITY AFFAIRS (SHRI MUKHTAR ABBAS NAQVI)

- (a) & (b) Ministry of Minority Affairs launched Upgrading the Skills and Training in Traditional Arts/ Crafts for Development (USTTAD) scheme on 14th May, 2015 to preserve the rich heritage of traditional arts/crafts of minorities. The scheme aims at capacity building and updating the traditional skills of master craftsmen/artisans; documentation of identified traditional arts/crafts of minorities; set standards for traditional skills; training of minority youths in various identified traditional arts/crafts through master craftsmen; and develop national and international market linkages. The training component of the scheme was started from 2016-17. Under the scheme, USTTAD Shilp Utsav component was implemented during 2015-16 and 2016-17. Hunar Haat is being implemented from 2016-17 as a component of USTTAD scheme. The Hunar Haat is an effective platform wherein opportunity is given to minority artisans/craftsmen and culinary experts from across the country to showcase and market their finest handicraft and exquisitely crafted indigenous products and has generated employment and employment opportunities for 2.65 lakh artisans, craftspersons and associated persons and has strengthened their market linkages. So far, 18 Hunar Haats have been organized through National Minorities Development & Finance Corporation (NMDFC) and Maulana Azad Education Foundation (MAEF) since November, 2016 at

(c) While the Ministry does not make State-wise allocation, so far 523 craftsmen and artisans under USTTAD Shilp Utsav component, 2,059 craftsmen and artisans under the Hunar Haat component and 23,760 trainees under the training in traditional arts/crafts component; totalling to 26,342 have been directly benefited under the USTTAD scheme. A State/year-wise statement, including State of Gujarat, showing details of craftsmen and artisans that have been benefited directly under USTTAD Shilp Utsav component is at **Annexure-II** and under the training in traditional arts/crafts component is at **Annexure-III**.

(d) The Government has taken up multi-media campaign to spread awareness of welfare schemes meant for minorities through print and electronic media, All India Radio Network including FM Channels, and websites all over the country. Pocket booklets and pamphlets on various schemes / programmes of the Ministry are published in Hindi, English, Urdu and other regional languages. In order to directly reach out to the public especially minority communities and spread awareness among them, 'Progress Panchayats' are organized in various places. Regional Coordination & Review Conferences are also held with State Governments from time to time where, inter-alia, information about the Ministry's schemes is provided. In addition, outdoor publicity is also being done by organizing 'Hunar Haat'. The Ministry also supports workshops and seminars organized by NGOs and State Organisations for creating awareness about its programmes and schemes.
