MEGA PARKS FOR AYURVEDIC MEDICINES

999. SHRI DHARAMBIR SINGH:

Will the Minister of **AYURVEDA, YOGA AND NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (AYUSH)** be pleased to state:

- (a) whether the Government proposes to set up mega park for the production of ayurvedic medicines in Haryana as part of the measures to promote indigenous medicines;
- (b) if so, the details thereof;
- (c) whether the Government has invited private investors for setting up each park;
- (d) if so, the number and details of investors who have shown interest in it till date; and
- (e) the budget earmarked for setting up such parks?

(a) to (e): As per the information received from Haryana State Directorate of AYUSH, there is no proposal in pipeline to setup mega park for the production of Ayurvedic Medicines. Ministry of AYUSH implemented a Central Sector Scheme for Development of Common Facilities for AYUSH Industry Clusters during the period of 11th and 12th Five Year Plans. The scheme intended to provide financial assistance to Special Purpose Vehicle (SPV) registered as a company formed by a group of at least 15 AYUSH enterprises located within 100 kilometers radius. The funding pattern was in the ratio of 60% of the project cost subject to maximum of Rs. 15.00 crore as grant in aid and 40% to be arranged by SPV through equity and borrowing from Banks/Financial Institutions and other sources for setting up common facilities of processing, manufacturing, testing, standardization, adoption of new technologies, scientific studies, marketing infrastructure, brand development, promotion etc. to encourage creation of social capital for collective initiatives in an industrial state, zone, park or area in a state. Details of the financial support provided under the scheme to set up ten AYUSH clusters are given in the annexure. In the current financial year, budget provision of Rs. 1.00 Crore existed at BE and Rs. 33.00 lakhs at RE.
