- (a) Government of India allocates and releases share of Central Taxes and Duties to States on the basis of accepted recommendations of the Finance Commission. State Governments use these releases for meeting their requirements in respect of all expenditures including on Centrally Sponsored Schemes.
- (b) State-wise details of share in Central Taxes and Duties allocated to the State Governments and released during last three years are enclosed as 'Annexure-I'.
- (c) Head-wise allocation of States' share in Central Taxes and Duties for Rajasthan for financial year 2020-21 is enclosed as 'Annexure-II'.
- (d) After the abolition of plan-non plan distinction in GoI Budget in 2017-18, the planwise details are the same as has been provided in part (c).
