1383. SHRI NIHAL CHAND: SHRIMATI JASKAUR MEENA:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether the Government has identified the works which can be executed through Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) in Rajasthan;
- (b) if so, the details thereof;
- (c) the details of the estimated amount for this work;
- (d) the details of the targets fixed in this regard; and
- (e) the time by which it is likely to be started?

ANSWER

MINISTER OF RURAL DEVELOPMENT (SHRI NARENDRA SINGH TOMAR)

Scheme (e) Mahatma Gandhi National Rural Employment (a) to Guarantee (Mahatma Gandhi NREGS) is a demand driven wage employment scheme with bottom up approach. The works are approved & prioritized by the Gram Sabha at the Gram Panchayat level in each States/UTs including Rajasthan. Accordingly the action plan (shelf of Work) of the permissible works are prepared & approved by the Gram Sabha under the scheme and can be taken up as per the demand. The planning of works is done as per the estimated person days to be generated for the work in the financial year at the time of assessment of labour budget. There is no target fixed for any specific work from the Ministry/Scheme, but are taken up as per the demand at the Gram Panchayat. Hence, no work-wise allocation of funds is made. During current financial year 2020-21, as on 15.09.2020, the Ministry has released Rs. 532300.15 lakh till now to Rajasthan for implementation of Scheme. The major category wise work status in Rajasthan under Mahatma Gandhi NREGA is given at Annexure.
