GOVERNMENT OFFICIALS ENGAGED IN CONTROLLING SPREAD OF COVID-19

1554. SHRI CHANDRA SEKHAR SAHU:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) the estimated number of Government officials engaged in controlling the spread of COVID-19 in the country, State-wise;
- (b) whether the Union Government will declare teachers and other Government officials engaged in the COVID-19 containment duty as the COVID-19 warriors;
- (c) if so, the details of family members of teachers who died during discharging their COVID-19 duties;
- (d) whether compensation has been given at par with the police and doctors in the country and if so, the details thereof, State-wise and district-wise in regard to Odisha; and
- (e) the number of families of such officials, whose family members have died of COVID, provided exgratia announced by the Government in the country so far, State-wise along with the amount provided?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NITYANAND RAI)

(a) to (c): Volunteers or government officials drafted by the Central/State/UT Government for care and who may have come in direct contact of the COVID-19 patient, can be declared by the

concerned designated authority as COVID warrior. As informed by Ministry of Health and Family Welfare, health is a State subject and data asked in part (a) and (c) is not centrally maintained.

(d): Volunteers or Government officials drafted on Covid-19 containment duty are covered under Pradhan Mantri Garib Kalyan Package (PMGKP) Insurance Scheme for health workers fighting COVID-19. The State-wise list of disbursement of ex-gratia payment made under PMGKP Insurance Scheme, is at Annexure.
