Will the Minister of COMMUNICATIONS be pleased to state:

- (a) whether the Department of Posts is increasingly earning revenues from non-traditional sectors like e-commerce and Payments Bank and if so, the details thereof;
- (b) the revenues earned by the Department of Posts in terms of percentage from various value added services/ non-traditional sectors during each of the last three years and the current year;
- (c) the future expansion plans proposed by the Government in the aforementioned sectors/services in the State of Tamilnadu; and
- (d) the number of Postal Payments Bank accounts in the said State, post office-wise?
