**SHARE OF SMALL INDUSTRIES**

†1855. SHRI PRATAPRAO JADHAV:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the share of small industries in comparison to organised sector in exports as on date;
- (b) the extent to which it has contributed in creating employment opportunities and wealth in the country;
- (c) whether any long term policy has been formulated for development of small industries; and
- (d) if so, the details thereof?

**ANSWER**

(a): As per the information received from Directorate General of Commercial Intelligence & Statistics, the Export of MSME related products and the share of Export of MSME related products in All India Export during 2018-19, 2019-20 and 2020-21 (till June,2020) was 48.10%, 49.75% and 42.52%, respectively.

(b): As per 73<sup>rd</sup> round of National Sample Survey (NSS) (July 2015- June 2016) conducted by Ministry of Statistics & Programme Implementation (MoSPI), the estimated employed persons in MSME Sector are about 11.10 crore.

As per the information received from Central Statistics Office, Ministry of Statistics & PI, MSME Gross Value Added (GVA) was 32.79% and 33.50% during the year 2017-18 and 2018-19 in All India GVA.

(c) to (d): The Ministry of Micro, Small and Medium Enterprises (MSME) implement various schemes to grow MSME sector and provide stimulus to MSMEs by various schemes and packages. These include Prime Minister's Employment Generation Programme (PMEGP), Micro and Small Enterprises-Cluster Development Programme (MSE-CDP), Scheme for Promotion of MSMEs in North Eastern Region and Sikkim, Tool Rooms and Technology Centers, Mission Solar Charkha (MSC), Scheme of Fund for Regeneration of Traditional Industries (SFURTI), Procurement and Marketing Support Scheme, Entrepreneurship Skill Development Programme (ESDP), Credit Guarantee Scheme for Micro and Small Enterprises (MSEs) and Credit Linked Capital Subsidy and Technology Upgradation Scheme (CLCS-TUS).

Recently, Post Covid-19, Government has taken a number of initiatives under Aatma Nirbhar Bharat Abhiyan to support the MSME Sector in the country especially in Covid-19 Pandemic. Some of them are:

- i) Rs 20,000 crore Subordinate Debt for MSMEs.
- ii) Rs 3 lakh crores Collateral free Automatic Loans for business, including MSMEs.
- iii) Rs. 50,000 crore equity infusion through MSME Fund of Funds.
- iv) New revised criteria for classification of MSMEs.
- v) New Registration of MSMEs through 'Udyam Registration' for Ease of Doing Business.
- vi) No global tenders for procurement up to Rs. 200 crores, this will help MSME.

An online Portal "Champions" has been launched on 01.06.2020 by Hon'ble Prime Minister. This covers many aspects of e-governance including grievance redressal and handholding of MSMEs. Through the portal, total 19,593 grievances have been redressed upto 17.09.2020.

RBI has also announced several measures to Reduce Financial Stress of MSMEs.
