Will the Minister of MICRO, SMALL & MEDIUM ENTERPRISES be pleased to state:

- (a) the disbursement of collateral-free loan amount to MSMEs under the Emergency Credit Line Guarantee Scheme (ECLGS) between 15 May and 1 September, 2020, State-wise;
- (b) the share of public sector banks and private sector banks in the disbursement of loans to the number of MSMEs under the said scheme, State-wise during the same period;
- (c) the latest occupational sector-wise break-up of number of MSMEs by total disbursed amount under the said scheme, State-wise;
- (d) the amount of lending by banks to MSMEs under the ECLGS between March and August 2020; and
- (e) whether the Government is considering enhancing credit guarantee schemes for MSMEs in lieu of property rates falling due to COVID-19 and if so, the details thereof?
