COVID-19 PATIENTS IN DELHI

2236. SHRI PARVESH SAHIB SINGH VERMA:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the number of COVID-19 patients in Delhi who were/are being treated in hospitals under the Central Government;
- (b) the steps taken by the Government for ensuring availability of beds to patients and their real time monitoring during the COVID-19 pandemic in such hospitals;
- (c) the amount spent on the treatment of COVID-19 patients in such hospitals; and
- (d) whether the Government has taken any measures for the post COVID-19 care of patients and if so, the details thereof and if not, the reasons therefor?

(a) The number of patients that availed treatment in the three Central Government Hospitals in Delhi namely Safdarjung, Dr. Ram Manohar Lohia and Lady Hardinge Medical College & Associated Hospitals as on 21/09/2020 is as under:

| Name of Hospital | Number of patients |

| Safdarjung Hospital | 2184 |
| Lady Hardinge Medical College and Smt. Sucheta Kriplani Hospital | 1362 |
| Dr. Ram Manohar Lohia Hospital | 3458 |

So far as All India Institute of Medical Sciences (AIIMS), Delhi is concerned, 6622 Covid-19 positive patients have been treated in AIIMS COVID Centers at (i) Jai Prakash Narayan Apex Trauma Centre (JPNATC), Delhi and (ii) National Cancer Institute (NCI), Jhajjar, till 19/09/2020.

(b) As far as the aforementioned Central Government Hospitals are concerned the number of beds available for corona patients is as under:

| Lady Hardinge Medical College and Smt. Sucheta Kriplani Hospital | 164 |
| Dr. Ram Manohar Lohia Hospital | 227 |
| All India Institute of Medical Sciences, Delhi (JPNATC & NCI) | 1515 |

Daily census of patients and vacancy position of beds are routinely and regularly monitored for ensuring availability of beds to patients during the COVID-19 pandemic in these hospitals.

(c) Hospital funds are being utilised for purchasing medical equipment, drugs and general store items for COVID-19 wards/ICU patient care services.

(d) As far as the above Central Government Hospitals are concerned, post COVID follow up clinics have been started for providing care to discharged patients of COVID ward.
