- (a) the quantum of budget allocated to and utilized by Patent Facilitation Cell (PFC) for implementation of various programmes/schemes/activities during the last two years and the current year;
- (b) the total number of patents that have been filed till date, Region-wise and Year-wise; and
- (c) whether the PFC offers financial help to startups and other young entrepreneurs to file the patents and if so, the details thereof?

- (a) Funds allocated to Patent Facilitation Cell (PFC) for Intellectual Property (IP) facilitation, conducting workshops & trainings on Intellectual Property Rights (IPR) and implementation of Women Scientist Scheme (WOS-C) was Rs 9.5 crore during the last two financial years i.e. 2018-19 and 2019-20. The funds were fully utilized for the purpose for which it was allocated. During the current financial year (2020-21), fund of Rs 75 lakh have been allocated to PFC for release.
- (b) Details of year-wise patent applications filed by PFC in India and other countries is given in following table:

(c) PFC does not offer any financial help to startups and other young entrepreneurs to file the patents as Department of Promotion of Industry and Internal Trade (DPIIT) is operating the Scheme for Facilitating Start-Ups Intellectual Property Protection (SIPP) through Office of the Controller General of Patents, Designs & Trade Marks for startups and other young entrepreneurs. However, about 10% of IP facilitators registered with Office of the Controller General of Patents, Designs & Trade Marks, engaged in IP facilitation activities under the SIPP scheme to help start-ups and other young entrepreneurs are from Women Scientist Scheme-C implemented by PFC.
