DAY-NRLM SCHEME IN MAHARASHTRA

270. SHRI SUNIL BABURAO MENDHE:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the allocation under the Deendayal Antyoday Yojana National Rural Livelihoods Mission (DAYNRLM) in the State of Maharashtra for the year 2019-2020, district-wise;
- (b) the number of Self Help Groups who have availed Aajeevika loans;
- (c) the type of benefits given to beneficiaries under the said scheme;
- (d) the amount released to the State of Maharashtra under the scheme during the last three years and the current year; and
- (e) the details of the amount released or likely to be released to Bhandara and Gondiya districts of Maharashtra under the scheme?

ANSWER

MINISTER OF RURAL DEVELOPMENT (SHRI NARENDRA SINGH TOMAR)

- (a): Under Deendayal Antyodaya Yojana National Rural Livelihoods Mission (DAY-NRLM) and National Rural Economic Transformation Project (NRETP) funds are allocated and released to States based on their approval of Annual Action Plan by the Empowered Committee of this Ministry. No funds are being released directly to Districts from this Ministry under these schemes. However, The allocation under DAY-NRLM in the state of Maharashtra for the year 2019-20 is 762.84 Crore (Both Central and State share). The district-wise allocation by Maharashtra State is attached at Annexure-I.
- (b): The number of Self Help Groups who have availed Aajeevika loans from the Banks during the last three years are as below:
