RURAL DEVELOPMENT SCHEME IN BHARATPUR DISTRICT

282. SHRIMATI RANJEETA KOLI:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether any schemes has been started for rural Development in Bharatpur District during the last three years;
- (b) if so, the amount released thereunder; and
- (c) if not, whether any scheme is under consideration in this regard for the next three years and if so, the details thereof?

ANSWER

MINISTER OF RURAL DEVELOPMENT (SHRI NARENDRA SINGH TOMAR)

(a): During last three years, though no new schemes have been started for rural development in the Bharatpur District of Rajasthan, ongoing Rural Development Schemes of the Government, started earlier than last three years, are being continued in the District. Details are provided at **Annexure-I.**

(c): The ongoing schemes will run till their validity unless decided otherwise, in Bharatpur District of Rajasthan.

1. Pradhan Mantri Gram Sadak Yojana (PMGSY)

Pradhan Mantri Gram Sadak Yojana (PMGSY) was launched in the year 2000 to provide all-weather road connectivity in rural areas. Details of PMGSY works sanctioned in Bharatpur District during last three years are as under:

Further, 17 roads of 127.83 km at the cost of Rs 89.44 crore has been sanctioned under PMGSY III in Bharatpur District during 2020-21.

2. Pradhan Mantri Awaas Yojana- Rural (PMAY-G)

The erstwhile Indira Awaas Yojana(IAY) has been restructured as Pradhan Mantri Awaas Yojana- Gramin(PMAY-G) w.e.f 1st April, 2016, aims to provide "Housing for All" through provision of pucca house with basic amenities to all houseless households and households living in kutcha and dilapidated house in rural areas by 2022. The overall target is to construct 2.95 Crore houses during the period 2016-17 to 2021-22, wherein 1 Crore house were set to be achieved in Phase-I (2016-17 to 2018-19) and 1.95 Crore houses in Phase-II (2019-20 to 2021-22).

3. Deendayal Antyodaya Yojana-National Rural Livelihoods Mission (DAY-NRLM)

6. National Social Assistance Programme (NSAP)

7. Shyama Prasad Mukherji National Rurban Mission (SPMRM)

No new scheme have been started for rural Development in Bharatpur District during last three years. However, under SPMRM, development of one cluster Jurahera, subdistrict Kaman, was initiated in the year 2016.

For cluster Jurahera under SPMRM, the total critical gap funds approved are Rs. 30 crore, and the total funds released till date is: Rs. 18 crore (Central Share Rs. 10.80 crore and State share Rs. 7.20 crore).

8. Saansad Adarsh Gram Yojana (SAGY)

A total of 3 Gram Panchayats have been identified in Bharatpur district. Further, the SAGY GPs have been successful in completing the implementation of 33 projects out of the 89 planned under their VDPs in Bharatpur district as per the information available on saanjhi.gov.in. It is stated that under the SAGY framework, the development of Gram Panchayats is envisaged through effective convergence and implementation of existing development Schemes of Government under the administrative control of respective Ministries without allocation of any additional fund.
