(a) the steps taken by the Government to facilitate the farmers and farming activities at field level during the lockdown period;

(b) whether the Government has launched Agri Transport Call Centre, if so, the details thereof;

(c) the amount of insurance claims disbursed to farmers under Pradhan Mantri Fasal Bima Yojna (PMFBY) between March to August, 2020, State-wise; and

(d) the quantum of pulses disbursed for delivery under Pradhan Mantri Garib Kalyan Yojana (PMGKY) to States from March to July, 2020, State-wise?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE

(a): During the COVID period, farming and allied activities were exempted from the lockdown. Seed, pesticide, fertilizer etc. dealers / shops and other input related activities were allowed to open / free for making inputs available to the farmers. Inter and intra state movement of farm machinery specially combine harvesters was facilitated. As a result of the various steps taken by the Department, both harvesting activities of the Rabi Crop and sowing activities of Summer Crop took place in a systematic manner.

(b): An Agri Transport Call Centre(ATCC) was set up initially in April 2020 as an emergency response to Covid-19.Subsequently due to relaxations from the lockdown as per Ministry of Home Affairs orders, the need for this facility was no longer felt and it was closed down in July 2020.

(c): Statement on insurance claims disbursed to farmers under Pradhan Mantri Fasal Bima Yojna (PMFBY) is at annexure - I.

(d): Statement on quantum of pulses disbursed for delivery under Pradhan Mantri Garib Kalyan Yojana (PMGKY) is at annexure - II.
