# LOK SABHA UNSTARRED QUESTION NO. 816 TO BE ANSWERED ON 17.09.2020

#### ARSENIC CONTAMINATED WATER

#### †816. SHRI GOPAL CHINNAYA SHETTY:

Will the Minister of **JAL SHAKTI** be pleased to state:

- (a) the steps taken by the Government to address the problem of contamination in cities/towns/areas reporting Arsenic contaminated drinking water;
- (b) the policy decisions taken by the Government to solve the problem during the last three years and the steps taken by the Government to spread country-wide awareness in this regard; and
- (c) the details of districts/towns/cities/areas which are in grip of Arsenic contamination, State/UT-wise?

#### **ANSWER**

### THE MINISTER OF STATE IN THE MINISTRY OF JAL SHAKTI (SHRI RATTAN LAL KATARIA)

(a)&(b) Government of Indiain partnership with States is implementing Jal Jeevan Mission – Har Ghar Jal to enable every rural household in the country to have potable water supply through Functional Household Tap Connection (FHTC) by 2024.

While allocating funds under JJM to States &UTs, 10% weightage has been given to the population affected by chemical contaminants including Arsenic. States/ UTs are advised to accord priority to quality-affected habitations. Further, States are also to provide interim relief in quality-affected habitations through community water purification plants (CWPP) to meet with drinking and cooking needs until potable water supply through tap connection is provided.

Under JJM, upto 2% of the allocation to States/ UTs can be utilized for Water Quality Monitoring & Surveillance activities (WQM&S)i.e. for setting up and strengthening of water quality testing laboratories, surveillance by community using field test kits(FTKs), awareness generation and educational programmes on water quality, etc.

In March 2017, National Water Quality Sub-Mission (NWQSM) was launched (now subsumed under JJM), with the aim to provide safe drinking water to 27,544 Arsenic/Fluoride affected habitations in the country.

Ministry of Housing and Urban Affairs has stated that the Atal Mission for Rejuvenation and Urban Transformation (AMRUT) launched by the Union Government on June 25, 2015, in selected 500 cities and towns across the country with focus on development of basic urban infrastructure in the Mission cities, *interalia* includes water supply. One of the key objectives of the Mission is to ensure that every household has access to a tap connection with assured supply of water and given first priority. Under AMRUT Mission, out of the total plan size of Rs.77,640 crore, Rs.39,010 crore (50%) has been allocated to water supply.
