## STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF THE LOK SABHA STARRED QUESTION NO. \*100 ASKED BY DR. ALOK KUMAR SUMAN, MP TO BE ANSWERED ON 8<sup>th</sup>FEBRUARY, 2021.

(a)Yes. Government proposes to promote the use of Compressed Natural Gas (CNG)/Piped Natural Gas (PNG) in Bihar. Following GAs/ Districts have been covered under City Gas Distribution (CGD) network in the state of Bihar:

- (b) Gopalganj district has not yet been authorized for development of CGD network. PNGRB identifies GAs for authorizing the development of CGD network in synchronization with the development of natural gas pipeline connectivity, natural gas availability and techno-commercial viability.
- (c) Saran district is adjacent to Gopalganj district in the state of Bihar, which has been covered under CGD network of Muzaffarpur, Vaishali, Saran and Samastipur Districts GA.
