- (a) whether the Government proposes to provide more digital facilities by connecting all the regions of the country through optical fibre network under the Digital India Scheme;
- (b) if so, the details thereof;
- (c) the number of villages connected by optical fibre cable so far, State/UT-wise; and
- (d) whether the mobile network connectivity and related facilities have started in all the villages of strategic importance and border areas and if so, the details thereof?

STATEMENT TO BE LAID ON THE TABLE OF LOK SABHA IN RESPECT OF PARTS (a) to (d) OF LOK SABHA STARRED QUESTION NO. 25 FOR 3RD FEBRUARY, 2021 REGARDING “DIGITAL FACILITY AND OPTICAL FIBRE CONNECTIVITY”.

(a) to (c) Yes Sir, Government of India is implementing BharatNet project to provide digital facilities through broadband connectivity to all the Gram Panchayats (GPs) (approx. 2,50,000) in the country mainly through Optical Fibre Cable (OFC). As on 15.01.2021, a total number of 1,44,678 Villages (Gram Panchayats) have been connected through OFC. State/UT-wise list is given at **Annexure-I**.

(d) State/UT-wise list of total inhabited villages as per Census 2011 and the number of villages covered with mobile connectivity in the country is given at **Annexure-II**.
