*356. SHRI SUNIL BABURAO MENDHE:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) Whether the Government encourages Non-Governmental Organizations (NGOs) for participating in environmental projects and to spread the environmental awareness in the country;
- (b) if so, the details regarding the schemes in place and the criteria laid down for funding requirements of the voluntary/professional/Non-Governmental organizations involved in the said project, and
- (c) the total funds granted to such NGOs for tiger conservation during the last three years in the State of Maharashtra?

- (a) and (b) Yes Sir. There are various schemes in the Ministry, which are carried out in participation with Voluntary/Professional/Non-Governmental Organizations, for the conservation of environment and spread awareness in the country. The major details of different schemes and criteria for NGOs to participate therein are enclosed as Annexure. The grants for environmental projects under various Schemes are sanctioned as per guidelines of respective Schemes. Each Organisation has to abide by the guidelines prescribed for grants under the scheme. Besides, each and every NGOs/VOs has to sign up on the Darpan Portal of the NITI Aayog and obtain a system generated Unique ID. The Unique ID is mandatory to apply for grants under various schemes of Ministry.
- (c) No funds have been granted to any NGO in Maharashtra State during the past three years by the Project Tiger Division/National Tiger Conservation Authority.

1.	Research and Development (R&D)	The scheme on R&D for conservation and development of environment is conceived to provide 'selective support' to Universities, reputed institutions, including NGOs/Professional organizations for specific projects on environmental protection
	(Central Sector Scheme)	and conservation of natural resources. The scheme is open to all institutions in the country with expertise in identified thematic areas to undertake projects on environmental protection and conservation of natural resources.
2.	Centre of Excellence (CoE) (Central Sector Scheme)	The Scheme was conceived to provide 'selective support' to Universities, reputed institutions including NGOs professional organisation and other scientific and technical institutions to enable them to develop into advanced centres at the national level in that particular subject area.

4.	Project Elephant (PE) (Centrally Sponsored Scheme)	lined project) are being supported.) Project Elephant aims at providing support to the States to conserve and protect viable population of elephants and to conserve/protect natural habitats and traditional corridors through eco-restoration or acquisition etc. Financial support under the scheme is provided to the State Governments for various activities for protecting elephants, improvement of habitats, census and monitoring of elephant population etc.
5.	Development of wild life habitats (DWLH) (Centrally Sponsored Scheme)	Grant-in-aid under the Development of wildlife habitat is provided to State/UT Administration for conservation and management of the Protected areas. The scheme also has a Central Sector component wherein the grant is provided for the Research Projects to various agencies including NGOs. Grants under the scheme are released to State Governments for (i) support to Protected areas, (ii) Protection of Wildlife outside protected areas and (iii) Recovery Program for critically endangered habitats and species.
6.	Environment Information System (ENVIS) (Central Sector Scheme)	ENVIS, serves as a single-stop web-enabled repository of comprehensive environmental information with collection, collation, storage, retrieval and dissemination through a nationwide network of ENVIS Hubs. Hazardous Substances Management (Central Sector Scheme)	NGOs/Societies engaged in promotion of waste management sector are eligible to seek financial assistance for conducting Capacity Building programmes and organizing awareness programmes with respect to environmentally sound management of chemicals and wastes.

Forestry and Capacity Building (Central Sector Scheme)	Funds are released to various agencies, including training institutions/organisations to impart in-service trainings to upgrade the managerial skills of the officers in changing socio-economic scenario of the country as also to expose them to the recent developments in the field of forestry and allied subject to enable them to handle their present duties and future needs more effectively.
10.	National Mission of Himalyan Study Scheme (Central Sector Scheme) Integrated Eco Development Research Programme (IERP)	NMHS – The Mission provides grants to various organisations viz. academic and research institutions, universities, government agencies, state governments as also the NGOs engaged towards strengthening the community participatory approach on certain key demand-driven developmental issues and interventions. The proposals must explicitly integrate the three NMHS cross-cutting themes of Climate Change, Gender Equality and Communications. IERP – The programme supports projects for financial assistance involving scientific research institutions, universities and NGOs
		working in IHR. (It is a programme of Central Govt. under GB Pant Institute of Himalayan Environment and Development and not a part of the scheme.)
