- (a) whether any evaluation of Skill Development Scheme has been conducted by third party agency as envisaged in the National Policy for Skill Development and Entrepreneurship;

- (c) whether any study has been done to determine that the skilled person under PMKVY get good wages in India and abroad; and
- (d) if so, details thereof?

ANSWER

(a) & (b): Yes, Sir. As envisaged in the National Policy for Skill Development and Entrepreneurship 2015, the Ministry of Skill Development and Entrepreneurship has been undertaking regular monitoring and evaluation of its various schemes / initiatives for any necessary corrective measures. (c) & (d): NSDC had engaged Sambodhi Research and Communications to conduct a third-party impact evaluation of PMKVY 2.0. The objective of the Study was to evaluate the impact of PMKVY Short Term Trainings (STT) and Recognition of Prior Learning (RPL). The Sambodhi Study found that the mean monthly income of individuals trained and certified under PMKVY 2.0 – STT was 15 percent higher when compared to a comparison group of individuals who has not participated in PMKVY. Further, the average monthly income of RPL-certified individuals was found to be 19 percent higher than that of a comparison group of non-RPL certified individuals.
