- (a) the schemes available along with the funds provided for the Rural areas to make them self-sufficient;
- (b) whether the funds allocated were utilised during the last five years; and
- (c) if so, the details thereof and if not, the reasons therefor?

(a) to (c) Ministry of Rural Development plays an important role for development of rural areas through employment generation, strengthening of livelihood opportunities, promoting self-employment, skilling of rural youths, provision of social assistance, infrastructure development, housing facilities etc. The Ministry is implementing Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS), Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY-NRLM), Deen Dayal Upadhyay – Gramin Kaushalya Yojana (DDU-GKY), Pradhan Mantri Awaas Yojana – Gramin (PMAY-G), Pradhan Mantri Gram Sadak Yojana (PMGSY), Shyama Prasad Mukherjee RURBAN Mission (SPMRM) and National Social Assistance Programme (NSAP). The funds allocated for rural development schemes are almost fully utilized by the Government. Details of Budget Allocation (Revised Estimate - RE) and Expenditure in respect of Rural Development Schemes for last 5 years is enclosed at **Annexure-1**.
