1315. SHRIMATI KESHARI DEVI PATEL:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- the number of beneficiaries allotted houses under Pradhan Mantri Awaas Yojana-Gramin (PMAY-G) in Prayagraj district of Uttar Pradesh;
- the funds allocated for the scheme during the financial years 2019-20 and 2020-2021;
- the number of beneficiaries allotted houses under the scheme during the said financial years; and
- the number of remaining eligible beneficiaries who have not been provided funds for houses under the scheme?

(a) To achieve the objective of “Housing for All” by the year 2022 in rural areas, the Pradhan Mantri Awaas Yojana- Gramin (PMAY-G) is being implemented w.e.f. from 1st April, 2016 in the country. A total target of 82,068 houses have been allocated to the Prayagraj District by the State. Out of the allocated target, 81,702 houses have been sanctioned and 52,129 houses have been completed in Prayagraj District of Uttar Pradesh since 2016-17 till 04.02.2021.

(b) The funds allocated to the scheme during the financial years 2019-20 and 2020-21 is given as under:

(d) Under PMAY-G, the target is to provide assistance to 2.95 crore eligible beneficiaries by 2021-22. Out of 2.02 crore eligible beneficiaries available in Permanent Wait List (PWL) of PMAY-G, sanctions have been given to 1.90 crore houses and funds for 1st instalment have been released to 1.75 crore beneficiaries and 1.28 crore houses have been completed during 2016-17 to 2020-21 (till 04.02.2021) under the scheme.
