#### HOUSES TO POOR UNDER PMAY-G

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether the Government has any data with regard to the number of houses provided to poor people under the Pradhan Manrti Awas Yojana Gramin (PMAYG) during the last three years;
- (b) if so, the details of houses sanctioned and allotted, State-wise specially in Jalore and Sirohi districts of Rajasthan and Latur, Satara and Solapur districts of Maharashtra;
- (c) the number of applications pending with the Government for allotment of houses to the poor under PMAY-G, State-wise including Jharkhand (specially Chatra, Latehar and Palam districts); and
- (e) the action taken by the Government for early approval?

#### **ANSWER**

### MINISTER OF RURAL DEVELOPMENT (SHRI NARENDRA SINGH TOMAR)

- (a) &(b): Yes Sir. Under Pradhan Mantri Awaas Yojana- Gramin (PMAY-G), the targets are set annually on the basis of availability of eligible beneficiaries, achievements of target allocated during the preceding years and proposal of the States/UTs. After allocation of Annual targets, further distribution amongst beneficiaries in various districts/blocks/villages is done by the States/UTs. The State-wise number of houses sanctioned and allotted especially in Jalore and Sirohi district of Rajasthan and Latur, Satara and Solapur districts of Maharashtra during the last three financial years is given in **Annexure**.
- (c)& (d):The selection of beneficiaries under PMAY-G is done by applying the deprivation / exclusion criteria on the Socio-Economic Caste Census (SECC), 2011 data followed by verification by Gram Sabhas and appellate process thereafter. A Permanent Wait List (PWL) of beneficiaries is thus generated. The PWL of the State of Jharkhand including Chatra, Latehar and Palam districts has been saturated with the targets under the Scheme. The State-wise number of houses allocated and sanctioned is given in **Annexure.**
