- (a) & (b):** The Department for Promotion of Industry & Internal Trade has supported Industrial Development Centres through 'Industrial Infrastructure Upgradation Scheme (IIUS)/Modified IIUS (MIIUS)'. 58 IIUS/MIIUS projects have been sanctioned in the country. Funds allocated and utilized by these Centres during last three years State & UT- wise are annexed (Annexure).
- (c) & (d):** Setting up of Industrial Development Centres across the country comes under the purview of the concerned State Government itself. However, Central Government provides support to the States through its schemes/programmes, once the proposal to develop the Industrial Development Centres/Parks/Clusters/Industries in a particular region is received from the concerned State Government.
