Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the schemes under the Ministry which helps common people to set up enterprises using easy credit;
- (b) the details of schemes under the Ministry and the funds allocated and utilized under those schemes during the last three years;
- (c) whether MSME Schemes have helped to increase the number of start-ups in the country and if so, the details thereof;
- (d) the details of different schemes available to launch a start-up/business; and
- (e) the details of employment generated through above schemes during the last three years?

MINISTER OF MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI NITIN GADKARI)

(a) to (e): Ministry of Micro, Small and Medium Enterprises (MSME) implements Prime Minister's Employment Generation Programme (PMEGP) for providing financial assistance to set up new enterprises. PMEGP is a major credit-linked subsidy programme aimed at generating self-employment opportunities through establishment of micro-enterprises in the non-farm sector by helping traditional artisans and unemployed youth. Year-wise details of the finance disbursed under the PMEGP of last three year.
