Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details of registered and unregistered Micro, Small and Medium Enterprises (MSMEs) owned by Scheduled Castes (SC)/Scheduled Tribes (ST) entrepreneurs in the country at present, State/UT-wise including Tamil Nadu;
- (b) the details of loans sanctioned to MSMEs under the MUDRA Yojana since the inception of the scheme and the number of enterprises owned by SC/ST entrepreneurs that received these loans, State/UT- wise;
- (c) whether the Government has made any assessment regarding the problems faced by the MSMEs owned by SC/ST entrepreneurs in obtaining loans, if so, the details and the outcome thereof along with the corrective steps taken/being taken by the Government in this regard;
- (d) whether MSMEs owned by SC/ST entrepreneurs have recorded any growth including their contribution to GDP and employment generation after implementation of 'Make in India' programme and if so, the details thereof; and
- (e) the other steps taken/being taken by the Government to help and encourage SC/ST entrepreneurs to establish MSMEs and to boost MSME sector in the country?

ANSWER

MINISTER OF MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI NITIN GADKARI)

- (a): As per Udyog Aadhaar Portal, number of MSMEs registered (since September 2015 to 30.06.2020) in All India owned by SC/ST was 9,12,399 and 2,98,690 respectively. The State/UT wise details are attached in annexure-I.
- (b): Under Pradhan Mantri Mudra Yojana (PMMY), collateral-free, institutional credit up to Rs. 10 lakh is provided by Member Lending Institutions (MLIs) viz. Public Sector Banks, Private Sector Banks, Regional Rural Banks, Small Finance Banks, Non Banking Finance Companies and Micro Finance Institutions to micro/small business units. State/UT wise detail of SC/ST borrowers availing loans under PMMY is attached in annexure-II.
- (c) to (e): Any complaints received in respect of implementation of PMMY including denial of loan applications, delay in turn-around-time (TAT) and lenders' insisting on collateral/ guarantor on certain occasions, are redressed in coordination with the respective banks.

COVID-19 epidemic has temporarily affected various sectors including Micro, Small and Medium Enterprises in the country including SC/ST entrepreneurs. As per the information received from Central Statistics Office, Ministry of Statistics & PI, the share of MSME GDP (including SC/ST MSMEs) in All India GDP (at constant prices) during 2018-19 and 2019-20 was 31.65% and 31.66% respectively.

The Ministry of Micro, Small and Medium Enterprises (MSMEs) implement various other schemes for the growth and development of MSME sector in the country including SC/ST entrepreneurs. These include Prime Minister Employment Generation Programme (PMEGP), Micro and Small Enterprises-Cluster Development Programme (MSE-CDP), Scheme of Fund for Regeneration of Traditional Industries (SFURTI), Credit Linked Capital Subsidy and Technology Upgradation Scheme (CLCS-TUS) and SC/ST Hub. In PMEGP, higher subsidy is given to SC/ST entrepreneurs in urban area 25% and rural area 35% of project cost. Under the Public Procurement Policy for MSEs, it is compulsory for all CPSEs to procure 25% from MSEs and out of total annual procurement from MSEs, 4% is earmarked for procurement from MSEs owned by SC/STs entrepreneurs. As on 09.02.2021, procurement amounting to Rs. 489.74 crores from 4776 SC/ST owned MSEs has been done. SC/ST hub supports SC/STs to take up entrepreneurship and ensures their effective participation in the Government Procurement process.

Recently, Post Covid-19, Government has taken a number of initiatives under Aatma Nirbhar Bharat Abhiyan to support the MSME Sector in the country especially in Covid-19 Pandemic. Some of them are:

- i) Rs 20,000 crore Subordinate Debt for MSMEs.
- ii) Rs 3 lakh crores Collateral free Automatic Loans for business, including MSMEs.
- iii) Rs. 50,000 crore equity infusion through MSME Fund of Funds.
- iv) New revised criteria for classification of MSMEs.
- v) New Registration of MSMEs through 'Udyam Registration' for Ease of Doing Business.
- vi) No global tenders for procurement up to Rs. 200 crores, this will help MSME.

An online Portal "Champions" has been launched on 01.06.2020 by Hon'ble Prime Minister. This covers many aspects of e-governance including grievance redressal and handholding of MSMEs including SC/ST entrepreneurs. Through the portal, total 26,693 grievances have been redressed upto 31.01.2021.
