Will the Minister of JAL SHAKTI pleased to state:

- (a) the salient features of Jal Jeevan Mission (JJM);
- (b) the funds sanctioned, allocated and utilized in Rajasthan under JJM during the last three years;
- (c) the details of the number of villages in Ganganagar and Dausa districts in Rajasthan covered thereunder;
- (d) the details of the targets set and achievements made under JJM so far particularly in regard to Ganganagar district; and
- (e) the steps taken by the Government to ensure speedy implementation of this Mission with a view to realizing its objectives in Rajasthan?

# ANSWER MINISTER OF STATE FOR JAL SHAKTI (SHRI RATTAN LAL KATARIA)

- (a) The key features of the Jal Jeevan Mission (JJM) are provisioning of potable water to every rural household through Functional Household Tap Connections (FHTCs) at a service level of 55 litre per capita per day (lpcd) of prescribed quality (BIS:10500) and supply on a regular and long-term basis.
- (b) The year-wise details of the Central fund allocated and drawn by the State of Rajasthan under erstwhile National Rural Drinking Water Programme (2017-18 & 2018-19) and JJM (2019-20) in last three years, is as under:

(d) At the time of announcement of JJM, 17% (3.23 Crore) rural households (HHs) in the country were having tap water connections and by 31.3.2021, it was planned to have tap water supply in 34% rural households. Against this, so far 3.43 Crore households have been provided with tap water connections and as on date, 34.80% (6.67 Crore) rural households have tap water supply in the country.

Since launch of JJM, 6.23 lakh (6.15%) households in Rajasthan have been provided with tap water connections. In the same period, about 46 thousand (15.52%) households have been provided with tap water connections in Ganganagar district.

(e) A number of steps have been taken to plan and implement JJM with speed, *inter alia* which includes planning, regular review of implementation, workshops and conferences for capacity building and knowledge sharing, field visits by multi-disciplinary team to provide technical support, etc. A detailed Operational Guidelines for the implementation of JJM, Margdarshika for the use of Gram Panchayats/ Village Water & Sanitation Committee/ Pani Samiti and 100–days campaign guidelines have been provided to States/ UTs to facilitate planning and implementation. For online monitoring, JJM–Integrated Management Information System and JJM–Dashboard has been put in place along with provision for transparent online financial management through Public Financial Management System (PFMS).
