#### **DEVELOPMENT OF BIO-ENERGY SYSTEM**

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) whether the Government has prepared any guidelines for development of bio-energy system in the country;
- (b) if so, the details thereof; and
- (c) the amount of financial assistance provided during the last three years and the current year for the said purpose, State-wise including Bihar?

### **ANSWER**

- (a) & (b) The Ministry is implementing the following schemes for development of bio-energy in the country:-
- 1. Scheme to support promotion of biomass based cogeneration in sugar mills and other industries. Under the scheme, Central Financial Assistance @ Rs 25 Lakhs / MW of surplus exportable capacity for bagasse cogeneration projects and Rs 50 Lakhs / MW of installed capacity for non-bagasse cogeneration projects is provided to cogeneration projects utilizing biomass like bagasse, agro-based industrial residue, crop residues, wood produced through energy plantations, weeds, wood waste produced in industrial operations, etc.
- **2. Programme on Energy from Urban, Industrial, Agricultural Wastes/ Residues and Municipal Solid Waste** for recovery of energy in the form of Biogas or BioCNG or Power from Urban, Industrial and Agricultural Waste / Residues such as MSW, vegetable and fruit market wastes, slaughterhouse waste, agricultural residues and industrial wastes & effluents. The financial assistance available under this Programme is as follows:
- a. Biogas generation: Rs 1.0 crore per 12000cum/day (Maximum Rs 10Cr/project);
- b. BioCNG generation (including setting of Biogas plant): Rs 4.0 Crore per 4800Kg/day (Maximum Rs 10Cr/project);
- c. Power generation based on Biogas (including setting of Biogas plant): Rs 1.5 Cr to Rs 3.0 Crore per MW(Maximum Rs 10Cr/project);

- d. Power generation from MSW: Rs 5.0 Crore per MW (Maximum Rs 50Cr/project);
- e. Power generation from solid waste other than MSW: Rs 0.50 Crore per MW (Maximum Rs 10Cr/project);

### f. Biomass Gasifier:

- Rs. 2,500 per kWe with duel fuel engines for electrical application
- Rs. 15,000 per kWe with 100% gas engines for electrical application
- · Rs. 2 lakh per 300 kWth for thermal applications.
- **3. New National Biogas and Organic Manure Programme (NNBOMP)** aims at setting up small biogas plants (1-25 m3) for meeting cooking energy and lighting needs of mainly rural and semi-urban households of the country. Under the NNBOMP Scheme, CFA is provided for setting up biogas plants of size from 1 m³ to 25 m³. The subsidy in the range of Rs. 7,500/- per plant of 1 m³ to Rs. 35,000/- per plant of 20 to 25 m³. Besides this, financial support is also provided for construction, supervision etc. There is also provision for support for skill development.
- **4. Biogas based Power Generation (Off-Grid) & Thermal energy application Programme (BPGTP)** provides clean energy solutions through biogas production to reduce consumption of diesel, kerosene and electricity by installation of medium size biogas plants of size 30 m<sup>3</sup> to 2500 m<sup>3</sup> per day with power generation installed capacity of 3 KW to 250 KW.
- (c) Financial assistance provided during the last three years and current year State-wise including Bihar is placed at **Annexure**.
