(a) & (b): Government of India is implementing Centrally Sponsored Scheme of National AYUSH Mission (NAM) through State/UT Governments including Telangana and West Bengal which envisages better access to AYUSH Services, Strengthening of AYUSH Educational Institutions; facilitate the enforcement of Quality Control of Ayurveda, Siddha, Unani & Homoeopathy (ASU&H) drugs and sustainable availability of ASU & H raw-materials in the States/UTs. Under NAM Grant-in-aid has been provided to the States/UTs including Telangana and West Bengal as per the proposals submitted by them in their State Annual Action Plans (SAAPs).
