(a) & (b): Yes Sir, Budget Estimates of Ministry of Culture for the year 2021-22 is at Annexure.

(c) & (d): Yes Sir, as per the mandate of Ministry of Culture, this Ministry deals with the tangible and Intangible Cultural Heritage of India. This heritage encompass several strands including monuments and archaeology, folk and tribal art, literature, archives, library, performing arts including music dance and drama, visual arts in the form of paintings, sculptures and graphics. All activities of the Ministry relating to promotion, preservation and conservation of the Cultural Heritage of the Country are implemented through a network of two attached offices, 6 subordinated offices and 34 autonomous organizations under its control and number of schemes directly operated by the Ministry for promotion and dissemination of Art & Culture. Its activities, projects and programmes are organized under various schemes of archeology, museums, archives, anthropology, performing arts, public libraries, Buddhists and Tibetan institutes, centenaries and anniversary, internal cultural relations, Gandhi heritage mission.
