Will the Minister of CULTURE be pleased to state :-

(a) the total number of Cultural Properties, Natural Properties and Mixed Sites from India declared as World Heritage sites by UNESCO as on date, State-wise and sitewise;

(b) the details of budget allocated and expenditure incurred on their maintenance and development during each of the last three years and the current year, site-wise;

(c) the action plan chalked out for proper and better maintenance of these sites and the progress made therein; and

(d) the total number of requests received by the Government for inclusion as World Heritage sites, State and site-wise?

ANSWER

THE MINISTER OF STATE (INDEPENDENT CHARGE) FOR CULTURE AND TOURISM

(a) At present, India has 38 World Heritage Properties. The details of World Heritage Properties are placed at **Annexure-I.**

(b) & (c) Expenditure details on World Heritage sites, protected by Ministry of Culture through Archaeological Survey of India (ASI), have been provided at **Annexure-II.** All the sites under the Ministry are conserved as per ASI's Conservation Policy and are in good shape.

(d) At present, India has 42 sites listed under Tentative List which is a pre-requisite condition for inscription as World Heritage Site. **'Dholavira: A Harappan City'** has been submitted for nomination of World Heritage Site in 2019-2020. Nomination dossiers of **'Santiniketan, India'** and **'Sacred Ensemble of Hoysalas'** have been submitted to UNESCO for the year 2021-22 cycle.

Augmentation of sites on the World Heritage List/Tentative List is a continuous process and sites are selected on the basis of their potential for fulfilling criteria under Operational Guidelines and demonstration of Outstanding Universal Value.
